Get prepared! Develop a disaster plan. Your plan should answer: What do you need to do to secure your home and property? Where will you go? Who will you notify as to your evacuation location? Also, you need to make a disaster kit with flashlights, batteries, water (1 gallon per person per day for at least 5 days), non-perishable food, battery operated weather radio and insurance information. # **SKATE PARK RULES & REGULATIONS**

The rules of the Chincoteague Skate Park reflect the same rules of the Veterans Memorial Park. It is unlawful for any person to ride, propel, push or otherwise operate a skateboard or inline skates on any public street, public sidewalk on Main Street or any other adjoining street between Jester Street and Maddox Blvd., public lots or other public property (except for public skateboard facilities and public sponsored or authorized skateboard events) within the Town limits.

### **Regulations.**

1. All skaters must wear appropriate safety equipment: helmet, kneepads, elbow pads and shoes.

**2**. Only skateboards and inline skates are permitted in the Skate Park.

**3**. Spectators are not permitted entry into the skate area unless wearing safety equipment.

- 4. Skater etiquette is expected at all times.
- 5. No glass is permitted in the Skate Park.

**6**. No alcohol or drugs are permitted on Town property.

7. No defacing of park property. Vandalism is subject to incarceration.

**8**. Personal property is the responsibility of the skater and may not be stored at the Skate Park.

**9**. No personal music devices allowed in the Skate Park.

10. No trespassing or skating when closed.

**11**. Profanity, recklessness and/or boisterous behavior is prohibited.

**12**. Any infraction of the rules will result in the loss of Skate Park privileges.

## **BULK TRASH POLICY & SCHEDULE**

The bulk trash collection provides for the collection of brush, appliances and furniture. Also, residents may dispose of mostly every other type of trash during the Spring (May) and Fall (September) cleanup collection.

Brush will be collected quarterly, on the 1st Thursday of January, April, July and October, with the quantity of brush collected at each household being limited to what would fill a full size pickup truck. Community brush piles are prohibited.

Appliances and furniture will be collected on the 1st Thursday of <u>every</u> month, limited to <u>2</u> items per household. Carpet and rug remnants will be considered as "other" trash and collected under the Spring and Fall cleanup.

All "other" bulk trash items will be collected on the 1st & 3rd Thursday of May and September, limited to a pickup truck load quantity.

It is important to note that the Town will <u>not</u> collect or accept through curbside collection, recycling center deposit, or the bulk trash service: tree stumps, construction and remodeling scraps, tires, petroleum products or byproducts, paint, waste fuel or oil, household solvents, or any other hazardous materials. Household garbage will not be collected during bulk trash collections.

To use the bulk trash service, residents will need to **place items curbside and call the Town office at 336-6519**, <u>48</u> hours in advance of a collection date to be placed on a collection list. Residents will be asked to provide the item(s) which are to be collected and their **911 address.** The Town will only collect from locations with such addresses.

#### SUPERVISOR THORNTON'S CORNER

I requested a meeting with the Army Corps of Engineers to discuss the criteria for Accomack County to start a 'Wetland Mitigation Bank'. Any wetland impacts, are costing tens of thousands of dollars for even a slight impact. Non profit or Town and County projects are required to pay also. The cost it adds to a project is significant and may prevent the project such as bike paths, community, town or county projects from going forward. The preferred alternative is mitigation, trading land impacts for other land. However, there is no Wetland Mitigation Bank on the Eastern Shore. It would benefit our county and town if we could get a Mitigation Bank approved. The Army Corps has been very helpful and we learned a lot at the meeting. I will continue to update the progress as it hopefully goes forward.
