#### 1. Call to Order

Mr. Leonard called the meeting to order at 7:30 pm.

2. Appeal 06-12-1 A request from Raymond Britton, agent for Capt. Fish's Inc., Parcel #30A1-1-39 and Parcel # 30A1-1-41 Main Street, for a variance from Article 3, section 3.12.2 of the zoning ordinance of the Town of Chincoteague. The petitioner wishes to construct a single family dwelling on each parcel. The petitioner wishes to place the structures 10' from the front lot line. Current zoning requires a minimum 25' front yard setback. This property is located in Resort Residential District R-4.

## Public Comments on Appeal

Mr. Britton spoke on his behalf. Mr. Britton advised that the parcel is a grandfathered non-conforming lot. The Corps of Engineers and the Wetlands Board staked out where he could build on the property.

Mr. Britton advised that he constructed a retaining wall where the approvals were given. Due to the small area left to build on, he is requesting to place the structures 10' from the front lot line.

## Board Action on Appeal

The Board questioned if the new structure would be 5' from the retaining wall. Mr. Britton advised yes.

The Board reviewed the plans of the new structure.

Board members felt that a 10' front yard setback to to close to the right of way. Motion by Mr. Gilliss, second by Mr. Moran to approve a 15' setback instead of the 10' setback requested. All approve. Motion carried.

<u>5. Appeal 06-12-2</u> A request from Barbara Wiedenheft, 6194 Clark Street, for a variance from Article 3, section 3.6.3 (2) of the zoning ordinance of the Town of Chincoteague. The petitioner wishes to construct a screen porch to the rear of the existing structure. The addition would be placed 19' from the rear lot line. Current zoning requires a minimum 25' rear yard setback. This property is located in R-2 Two Family Residential.

# 6. Public Comments on Appeal

Mrs. Wiedenheft spoke on her behalf. Mrs. Wiedenheft advised she needed a place where her and her husband can set out in the yard and not get attacked by mosquitoes. Mrs. Wiedenheft advised she has extreme allergies to mosquitoes.

The rear of the yard is separated by a small right of way that goes to a house in the back. Mrs. Wiedenheft felt that right of way gives more separation to the house in the rear.

# Board Action on Appeal

The Board voiced their concerns about the owners changing the use of the screen porch into part of the residence in the future.

Motion by Mr. Thornton, Second by Mr. Moran to approve the setback request with the condition that the addition can only be a screen porch. All in favor. Motion carried.

# 8. Election of Chairman & Vice-Chairman

Due to Mr. Leonard being elected to the Town Council his seat on the Board expires on June 30, 2012.

Mr. Thornton motioned, second by Mr. Gilliss to appoint Mr. Speidel as Chairman and Mr. Cherrix as Vice-Chairman. All in favor. Motion carried.

Mr. Leonard adjourned the meeting.
